MUTUAL AID AGREEMENT

THIS AGREEMENT IS MADE AND ENTERED INTO, BY AND AMONG THE UNDERSIGNED FIRE PROTECTION DISTRICTS AND CITIES OF CHELAN, DOUGLAS AND GRANT COUNTY AS NOTED ON PAGE 4 OF THIS AGREEMENT.

WITNESSETH:

PURSUANT TO THE AUTHORITY VESTED IN THE PARTIES BY THE PROVISIONS OF RCW 35.84.040 AND RCW 52.12.111 THE UNDERSIGNED PARTIES MUTUALLY AGREE AS FOLLOWS:

WHEREAS, EACH OF THE PARTIES MAINTAIN OR CONTRACT FOR EQUIPMENT AND PERSONNEL FOR THE PURPOSE OF COMBATING AND SUPPRESSING FIRES AND RESPONDING TO OTHER EMERGENCIES WITHIN IT'S OWN JURISDICTION AND;

WHEREAS, EACH OF THE PARTIES DESIRES TO AUGMENT THE FIRE PROTECTION, RESCUE, AND OTHER EMERGENCY RESPONSE CAPABILITY AVAILABLE IN IT'S RESPECTIVE JURISDICTION IN THE EVENT OF A FIRE OR EMERGENCY SITUATION; AND

WHEREAS, EACH OF THE PARTIES DESIRES TO MAINTAIN ADEQUATE PROTECTION IN IT'S RESPECTIVE JURISDICTION WITH THE USE OF MOVE-UP OR STANDBY ASSISTANCE; AND

WHEREAS, THE LANDS, AREAS, BUILDINGS, AND PROPERTIES WITHIN THE JURISDICTION OF THE PARTIES HERETO ARE WITHIN SUCH DISTANCE FROM EACH OTHER THAT MUTUAL AID IN AN EMERGENCY SITUATION IS DEEMED FEASIBLE; AND

WHEREAS, IT IS DEEMED SOUND, DESIRABLE, PRACTICABLE AND BENEFICIAL FOR THE PARTIES TO THIS AGREEMENT TO RENDER ASSISTANCE TO ONE ANOTHER IN ACCORDANCE WITH THESE TERMS;

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS OF THE PARTIES HERETO, THE PARTIES AGREE AS FOLLOWS;

SECTION 1. COMMENCEMENT

THIS AGREEMENT SHALL BE DEEMED EFFECTIVE AS TO EACH PARTY WHEN THE LEGISLATIVE BODY OF THAT PARTY HAS APPROVED THIS AGREEMENT AND HAS FILED A SIGNED COPY WITH THE CHELAN COUNTY DEPARTMENT OF EMERGENCY MANAGEMENT.

SECTION 2. WHEN ENFORCEABLE

WHENEVER MUTUAL AID IS DEEMED APPROPRIATE AND NECESSARY BY THE OFFICER IN CHARGE OF THE FIRE DEPARTMENT OR DISTRICT OF ANY PARTY HERETO, BY REASON OF FIRE OR OTHER EMERGENCY SITUATION WITHIN SUCH PARTY'S JURISDICTION, OR FOR MOVE-UP OR STANDBY ASSISTANCE, HE IS AUTHORIZED TO REQUEST ASSISTANCE UNDER TERMS OF THIS AGREEMENT FROM THE APPROPRIATE PARTICIPATING PARTY OR PARTIES.

SECTION 3. SUPERVISION

THE OFFICER IN CHARGE OF THE FIRE DEPARTMENT AND/OR DISTRICT REQUESTING ASSISTANCE (UNLESS HE HAS DELEGATED HIS AUTHORITY) SHALL ASSUME FULL CHARGE OF THE OPERATIONS. THE SUPERVISORS OF THE PARTIES RENDERING ASSISTANCE SHALL REPORT TO THE OFFICER IN CHARGE AND BE UNDER HIS COMMAND.

THE PERSONNEL AND EQUIPMENT OF THE PARTY RENDERING ASSISTANCE SHALL REMAIN UNDER THE IMMEDIATE SUPERVISION AND RESPONSIBILITY OF THE OFFICE IN CHARGE OF SUCH UNIT RENDERING ASSISTANCE.

SECTION 4. RESPONSIBILITIES

THE PARTY RENDERING ASSISTANCE SHALL BE RESPONSIBLE FOR THE DELIVERY OF REQUESTED EQUIPMENT AND MANPOWER AS REQUESTED, PROVIDED, HOWEVER, THAT:

- THE PARTY RENDERING ASSISTANCE UNDER THIS AGREEMENT SHALL NOT BE REQUIRED TO MAKE RESOURCES AVAILABLE OR RENDER SERVICES TO ANY OTHER PARTY WHEN, BY SO DOING, ANY UNREASONABLE DANGER TO LIVES AND/OR PROPERTY OF THAT PARTY'S JURISDICTION WOULD RESULT.
- THE PARTY RENDERING ASSISTANCE SHALL DETERMINE WHAT RESOURCES AND SERVICES CAN REASONABLY BE MADE AVAILABLE.
- EACH PARTY SHOULD INSURE THAT ONE ENGINE COMPANY, WITH ADEQUATE MANNING, BE AVAILABLE FOR SERVICE WITHIN IT'S RESPECTIVE JURISDICTION AT ALL TIMES, EITHER WITH IT'S OWN RESOURCES OR WITH MOVE-UP OR STANDBY ASSISTANCE.

SECTION 5. PAYMENTS

THE PARTY REQUESTING ASSISTANCE UNDER THIS AGREEMENT SHALL NOT BE RESPONSIBLE FOR THE PAYMENT FOR SERVICES RENDERED. HOWEVER, THE PARTY REQUESTING ASSISTANCE SHALL BE RESPONSIBLE FOR PROVIDING, AT THE SCENE, OPERATING SUPPLIES FOR EQUIPMENT AND WELFARE ITEMS FOR PERSONNEL, AS DEEMED NECESSARY.

SECTION 6. LIABILITY

EACH PARTY HERETO ASSUMES FULL RESPONSIBILITY FOR NORMAL MAINTENANCE AND REPAIR, AND LIABILITY FOR PROPERTY DAMAGE TO IT'S OWN PROPERTY, PERSONAL INJURY AND/OR DEATH TO IT'S PERSONNEL ARISING OUT OF IT'S PERFORMANCE OF THIS AGREEMENT, WHEN SUCH LOSS, DAMAGE, PERSONAL INJURY AND/OR DEATH OCCURS AS A RESULT OF IT'S OWN ACTION OR INACTION, ABSENT THE NEGLIGENCE OF ANY OTHER PARTY PROXIMATELY CONTRIBUTING TO SUCH LOSS OR INJURY.

IN THE EVENT THERE IS ANY LOSS, DAMAGE, PERSONAL INJURY, DEATH OR PROPERTY DAMAGE CAUSED BY ANY PARTY'S NEGLIGENCE, THEN SAID PARTY SHALL BE RESPONSIBLE FOR SUCH DAMAGE OR INJURY AND DOES HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS ANY OTHER PARTY AS TO ANY SUCH DAMAGE OR INJURY, INCLUDING ALL COSTS, EXPENSES AND ATTORNEY FEES.

EACH PARTY TO THIS AGREEMENT AGREES TO MAINTAIN AT ALL TIMES, AT IT'S SOLE EXPENSE, PUBLIC LIABILITY INSURANCE, ON AN OCCURRENCE BASIS, FOR THE JOINT AND SEPARATE PROTECTION OF ITSELF AND THE OTHER PARTIES, IN THE MINIMUM AMOUNT OF ONE MILLION DOLLARS (\$1,000,000.00) IN CASE OF INJURY TO ANY PERSON, OR IN THE CASE OF INJURY TO MORE THAN ONE PERSON IN THE SAME OCCURRENCE, AND IN THE MINIMUM AMOUNT OF ONE MILLION DOLLARS (\$1,000,000.00) FOR PROPERTY DAMAGE.

SECTION 7. INVENTORY

EACH PARTY TO THIS AGREEMENT WILL FURNISH AN INVENTORY OF IT'S FACILITIES, EQUIPMENT AND MANPOWER TO THE CHELAN COUNTY DEPARTMENT OF EMERGENCY MANAGEMENT. SAID INVENTORIES WILL BE REVIEWED AND UPDATED ANNUALLY.

SECTION 8. DURATION

THIS AGREEMENT SHALL TAKE EFFECT UPON THE SIGNATURE OF EACH PARTY AND SHALL REMAIN IN FORCE AND EFFECT UNTIL CANCELED BY MUTUAL AGREEMENT OF ALL THE PARTIES HERETO OR BY WRITTEN NOTICE BY ONE PARTY TO ALL OTHER PARTIES GIVING THIRTY (30) DAYS NOTICE IN WRITING OF THAT PARTY'S INTENT TO WITHDRAW

SECTION 9. SUPERSEDING DOCUMENT

THIS MUTUAL AID AGREEMENT SHALL SUPERSEDE THE PREVIOUS FIRE SERVICES MUTUAL AID AGREEMENT, DATED 1992, FOR THE UNDERSIGNED PARTIES.

SECTION 10. SEVERABILITY

IN THE EVENT ANY PROVISION OF THIS AGREEMENT IS HELD INVALID, SUCH INVALIDITY SHALL NOT AFFECT OTHER TERMS OF THIS AGREEMENT WHICH CAN BE GIVEN EFFECT WITHOUT THE INVALID PROVISION. TO THIS END, THE PROVISIONS OF THIS AGREEMENT ARE DECLARED SEVERABLE.

THIS AMENDMENT TO THE 1996 MUTUAL AID AGREEMENT IS MADE AND ENTERED INTO, BY AND AMONG THE UNDERSIGNED FIRE PROTECTION DISTRICTS AND CITIES OF CHELAN, DOUGLAS AND GRANT COUNTY AS NOTED ON PAGE 2 OF THIS AMENDMENT TO THE AGREEMENT.

A NEW SECTION TO THE AGREEMENT IS ADDED:

SECTION 11. PRE-EMERGENCY PLANNING / AUTOMATIC AID

THE COMMANDING OFFICERS OF EACH PARTY HERETO MAY, FROM TIME TO TIME, MUTUALLY ESTABLISH PRE-EMERGENCY PLANS. WHICH MAY INCLUDE AUTOMATIC MUTUAL AID, WHICH SHALL INDICATE THE TYPES OF AND LOCATIONS OF POTENTIAL PROBLEM AREAS WHERE EMERGENCY ASSISTANCE MAY BE NEEDED, THE TYPE OF EQUIPMENT THAT SHOULD BE DISPATCHED UNDER VARIOUS POSSIBLE CIRCUMSTANCES, AND THE NUMBER OF PERSONNEL THAT SHOULD BE DISPATCHED UNDER SUCH CIRCUMSTANCES. SUCH PLANS SHALL TAKE INTO CONSIDERATION AND INSURE PROPER PROTECTION BY THE RESPONDING PARTY WITHIN IT'S RESPECTIVE JURISDICTION.

SECTION 3. SUPERVISION

THE OFFICER IN CHARGE OF THE FIRE DEPARTMENT AND/OR DISTRICT REQUESTING ASSISTANCE (UNLESS HE HAS DELEGATED HIS AUTHORITY) SHALL ASSUME FULL CHARGE OF THE OPERATIONS. THE SUPERVISORS OF THE PARTIES RENDERING ASSISTANCE SHALL REPORT TO THE OFFICER IN CHARGE AND BE UNDER HIS COMMAND.

THE PERSONNEL AND EQUIPMENT OF THE PARTY RENDERING ASSISTANCE SHALL REMAIN UNDER THE IMMEDIATE SUPERVISION AND RESPONSIBILITY OF THE OFFICE IN CHARGE OF SUCH UNIT RENDERING ASSISTANCE.

SECTION 4. RESPONSIBILITIES

THE PARTY RENDERING ASSISTANCE SHALL BE RESPONSIBLE FOR THE DELIVERY OF REQUESTED EQUIPMENT AND MANPOWER AS REQUESTED, PROVIDED, HOWEVER, THAT:

- THE PARTY RENDERING ASSISTANCE UNDER THIS AGREEMENT SHALL NOT BE REQUIRED TO MAKE RESOURCES AVAILABLE OR RENDER SERVICES TO ANY OTHER PARTY WHEN, BY SO DOING, ANY UNREASONABLE DANGER TO LIVES AND/OR PROPERTY OF THAT PARTY'S JURISDICTION WOULD RESULT.
- THE PARTY RENDERING ASSISTANCE SHALL DETERMINE WHAT RESOURCES AND SERVICES CAN REASONABLY BE MADE AVAILABLE.
- EACH PARTY SHOULD INSURE THAT ONE ENGINE COMPANY, WITH ADEQUATE MANNING, BE AVAILABLE FOR SERVICE WITHIN IT'S RESPECTIVE JURISDICTION AT ALL TIMES, EITHER WITH IT'S OWN RESOURCES OR WITH MOVE-UP OR STANDBY ASSISTANCE.

SECTION 5. PAYMENTS

THE PARTY REQUESTING ASSISTANCE UNDER THIS AGREEMENT SHALL NOT BE RESPONSIBLE FOR THE PAYMENT FOR SERVICES RENDERED. HOWEVER, THE PARTY REQUESTING ASSISTANCE SHALL BE RESPONSIBLE FOR PROVIDING, AT THE SCENE, OPERATING SUPPLIES FOR EQUIPMENT AND WELFARE ITEMS FOR PERSONNEL, AS DEEMED NECESSARY.

SECTION 6. LIABILITY

EACH PARTY HERETO ASSUMES FULL RESPONSIBILITY FOR NORMAL MAINTENANCE AND REPAIR, AND LIABILITY FOR PROPERTY DAMAGE TO IT'S OWN PROPERTY, PERSONAL INJURY AND/OR DEATH TO IT'S PERSONNEL ARISING OUT OF IT'S PERFORMANCE OF THIS AGREEMENT, WHEN SUCH LOSS, DAMAGE, PERSONAL INJURY AND/OR DEATH OCCURS AS A RESULT OF IT'S OWN ACTION OR INACTION, ABSENT THE NEGLIGENCE OF ANY OTHER PARTY PROXIMATELY CONTRIBUTING TO SUCH LOSS OR INJURY.

IN THE EVENT THERE IS ANY LOSS, DAMAGE, PERSONAL INJURY, DEATH OR PROPERTY DAMAGE CAUSED BY ANY PARTY'S NEGLIGENCE, THEN SAID PARTY SHALL BE RESPONSIBLE FOR SUCH DAMAGE OR INJURY AND DOES HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS ANY OTHER PARTY AS TO ANY SUCH DAMAGE OR INJURY, INCLUDING ALL COSTS, EXPENSES AND ATTORNEY FEES.

EACH PARTY TO THIS AGREEMENT AGREES TO MAINTAIN AT ALL TIMES, AT IT'S SOLE EXPENSE, PUBLIC LIABILITY INSURANCE, ON AN OCCURRENCE BASIS, FOR THE JOINT AND SEPARATE PROTECTION OF ITSELF AND THE OTHER PARTIES, IN THE MINIMUM AMOUNT OF ONE MILLION DOLLARS (\$1,000,000.00) IN CASE OF INJURY TO ANY PERSON, OR IN THE CASE OF INJURY TO MORE THAN ONE PERSON IN THE SAME OCCURRENCE, AND IN THE MINIMUM AMOUNT OF ONE MILLION DOLLARS (\$1,000,000.00) FOR PROPERTY DAMAGE.

SECTION 7. INVENTORY

EACH PARTY TO THIS AGREEMENT WILL FURNISH AN INVENTORY OF ITS FACILITIES, EQUIPMENT AND MANPOWER TO THE CHELAN COUNTY DEPARTMENT OF EMERGENCY MANAGEMENT. SAID INVENTORIES WILL BE REVIEWED AND UPDATED ANNUALLY.

SECTION 8. DURATION

THIS AGREEMENT SHALL TAKE EFFECT UPON THE SIGNATURE OF EACH PARTY AND SHALL REMAIN IN FORCE AND EFFECT UNTIL CANCELED BY MUTUAL AGREEMENT OF ALL THE PARTIES HERETO OR BY WRITTEN NOTICE BY ONE PARTY TO ALL OTHER PARTIES GIVING THIRTY (30) DAYS NOTICE IN WRITING OF THAT PARTY'S INTENT TO WITHDRAW

SECTION 9. SUPERSEDING DOCUMENT

THIS MUTUAL AID AGREEMENT SHALL SUPERSEDE THE PREVIOUS FIRE SERVICES MUTUAL AID AGREEMENT, DATED 1992, FOR THE UNDERSIGNED PARTIES.

SECTION 10. SEVERABILITY

IN THE EVENT ANY PROVISION OF THIS AGREEMENT IS HELD INVALID, SUCH INVALIDITY SHALL NOT AFFECT OTHER TERMS OF THIS AGREEMENT WHICH CAN BE GIVEN EFFECT WITHOUT THE INVALID PROVISION. TO THIS END, THE PROVISIONS OF THIS AGREEMENT ARE DECLARED SEVERABLE.
